# **BRIEF SUMMARY OF THE FACTS**

In the parallel proceedings ACT\_583273/2023 UPC\_CFI\_390/2023 concerning EP 2 867 997, the Board has postponed the date for pronouncing a decision from 6 to 13 September 2024.

The plaintiff then stated that it would be sensible and expedient to postpone the date of the oral proceedings in the present case until after the judgment has been handed down.

The defendants have already indicated their agreement to a postponement in the course of an e-mail correspondence between the Board and the parties' representatives.

From the point of view of the plaintiff, it would be preferable to stick to the trial date in the third proceedings (ACT\_463961/2023) for EP233 and to find an alternative date for EP863 in the near future. The proceedings concerning EP233 are of greater relevance to the plaintiff than the proceedings concerning EP863, partly because of the broader territorial scope of protection of EP233 compared to EP863.

# THE PARTIES' REQUESTS

The applicant requests:

the postponement of the date of the oral proceedings (11 September 2024) to a later date.

The defendants have agreed.

#### JUDGMENT

After consulting the other members of the bench, the request is granted and the date is postponed to 23 October 2024.

It will be decided at a later date whether the two proceedings ACT\_459762/2023 UPC\_CFI\_5/2023 concerning EP 2 372 863 and ACT\_463961/2023 UPC\_CFI\_62/2023 concerning EP 2 628 233 will be heard on that date or whether one of these proceedings will be rescheduled.

1. The hearing date of 11 September 2024 is postponed to 23 October 2024, 9.00 a.m., Munich Local Division, Room 212, Denisstr. 3 in Munich.

2. The parties will be invited to this new date.
